

Membership

(i) Eligibility

A person may become a member of the TGSCCC by fulfilling the conditions for membership specified by the administrative policies, procedures and directives of the TG Silundika Cultural Community Centre & Memorial Library (see below)

(ii) Assumption of Membership

- ✓ A person shall apply for membership by entering personal information on the
- ✓ TGSCCC application form.
- ✓ The form is submitted to the Management Committee
- ✓ The applicant is required to pay the prescribed joining fee before the application
- √ is considered.
- ✓ Upon receipt of the application, the secretary of the committee shall make
- ✓ contact indicating that the applicant has been accepted as a provisional member.
- ✓ The period of provisional membership shall be 6 months during which the
- ✓ applicant(s) shall have access to the full range of services offered by the Centre.
- ✓ The Management Committee shall, at its discretion, grant or refuse membership
- ✓ and the applicant shall be duly notified.

All members shall enjoy the right to:

- ✓ Attend, speak and vote during the annual general meeting (AGM).
- ✓ Inspect minutes or any records of any annual general meeting.
- ✓ Participate in all the activities and programs of the centre.
- ✓ Inspect the membership register.

Membership Fees

- ✓ Due to current economic hardships in Zimbabwe, citizens resident in the country
- ✓ will be exempted from paying membership fees until further notice.
- ✓ For diaspora based citizens and international applicants the fee is US\$10.00
- ✓ renewable every year.



Discipline

With the centre's vision to establish a standard of excellence in cultural heritage sustainability and communinity development in southern Africa, a strict code of conduct will be enforced as a necessary step towards the realization of our goals.

The following shall constitute offences that may result in withdrawal of membership and in some cases outright prosecution.

- 1. Spreading false information about the centre
- 2. Using indecent language
- 3. Publishing information aimed at tarnishing the image of the centre
- 4. Gross insubordination
- 5. Defrauding the centre of funds
- 6. Unauthorized solicitation of funds from the public
- 7. Fraudulent practices
- 8. Discrimination based on gender, race, tribe, religion or national origin
